

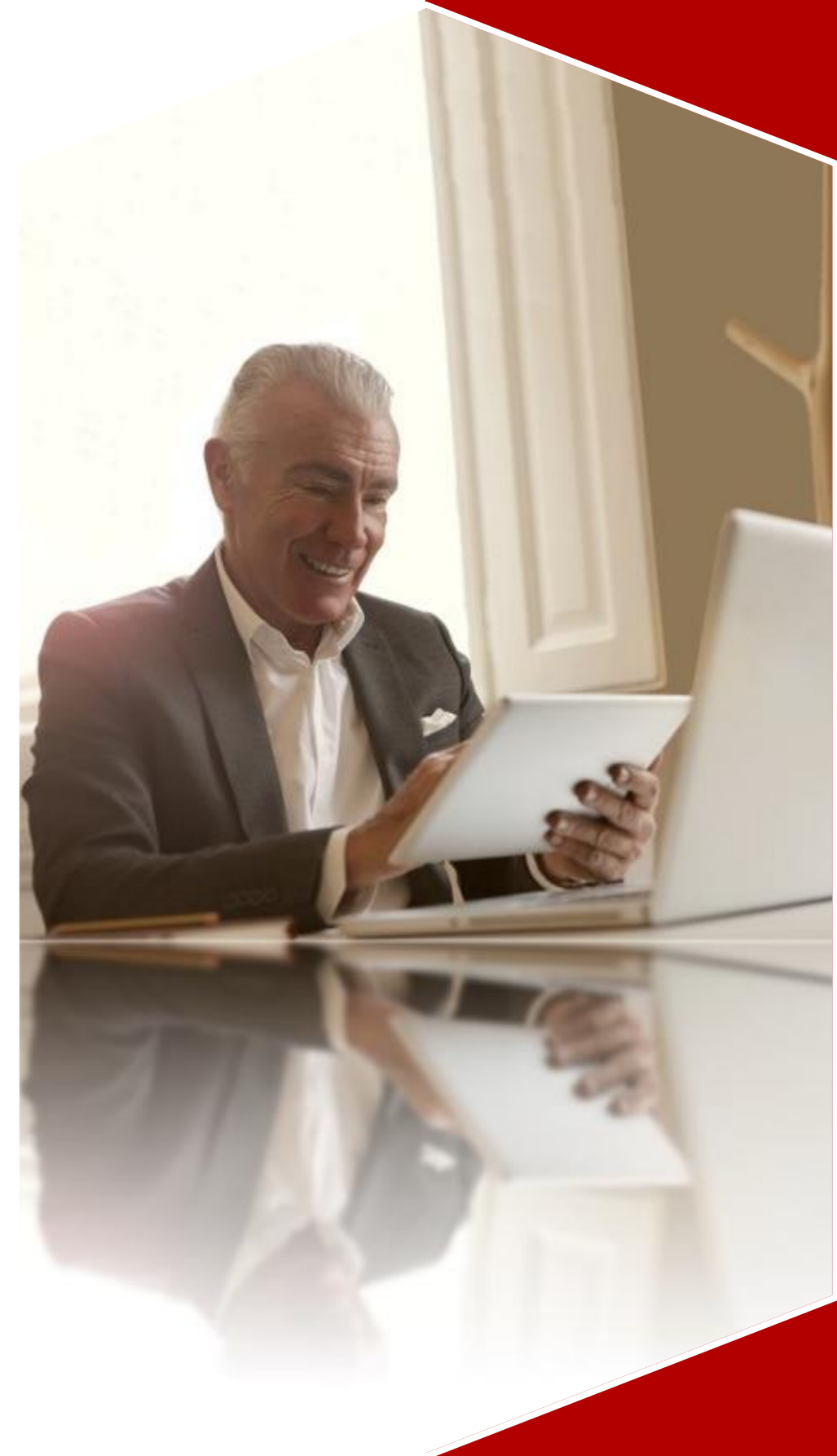
INVESTOR VISA

REQUIREMENTS

- ✓ Have £2,000,000 or more to invest in the UK
- ✓ Be able to prove that the money belongs to either you or your husband, wife, unmarried or same-sex partner
- ✓ Have opened an account at a UK regulated bank to use for your funds
- ✓ Your funds held in one or more regulated financial institutions
- ✓ Free to spend ('disposable') in the UK

ROUTE TO PERMANENT RESIDENCE

You may apply for permanent residence after 2 years if you invest £10 million, after 3 years if you invest £5 million or after 5 years if you invest £2 million.





OVERSEAS BUSINESS REPRESENTATIVE VISA

REQUIREMENTS

- ✓ Be recruited and employed outside the UK by an active and trading business (whose headquarters and principal place of business are, and will remain, outside the UK)
- ✓ Have the skills, experience and knowledge to do the role
- ✓ Hold a senior position within the business (but do not own or control the majority of it) and have full authority to make decisions on its behalf
- ✓ Intend to establish the overseas business's first commercial presence in the UK, either as a registered branch or a wholly owned subsidiary
- ✓ Have a minimum level of English Language at least CEFR level A1 in speaking and listening

ROUTE TO PERMANENT RESIDENCE

A Representative of an Overseas Business visa can be extended for up to 2 years after the original visa duration of 3 years. You can apply to settle once you have been in the UK for 5 years and you have an ongoing job with the same company.

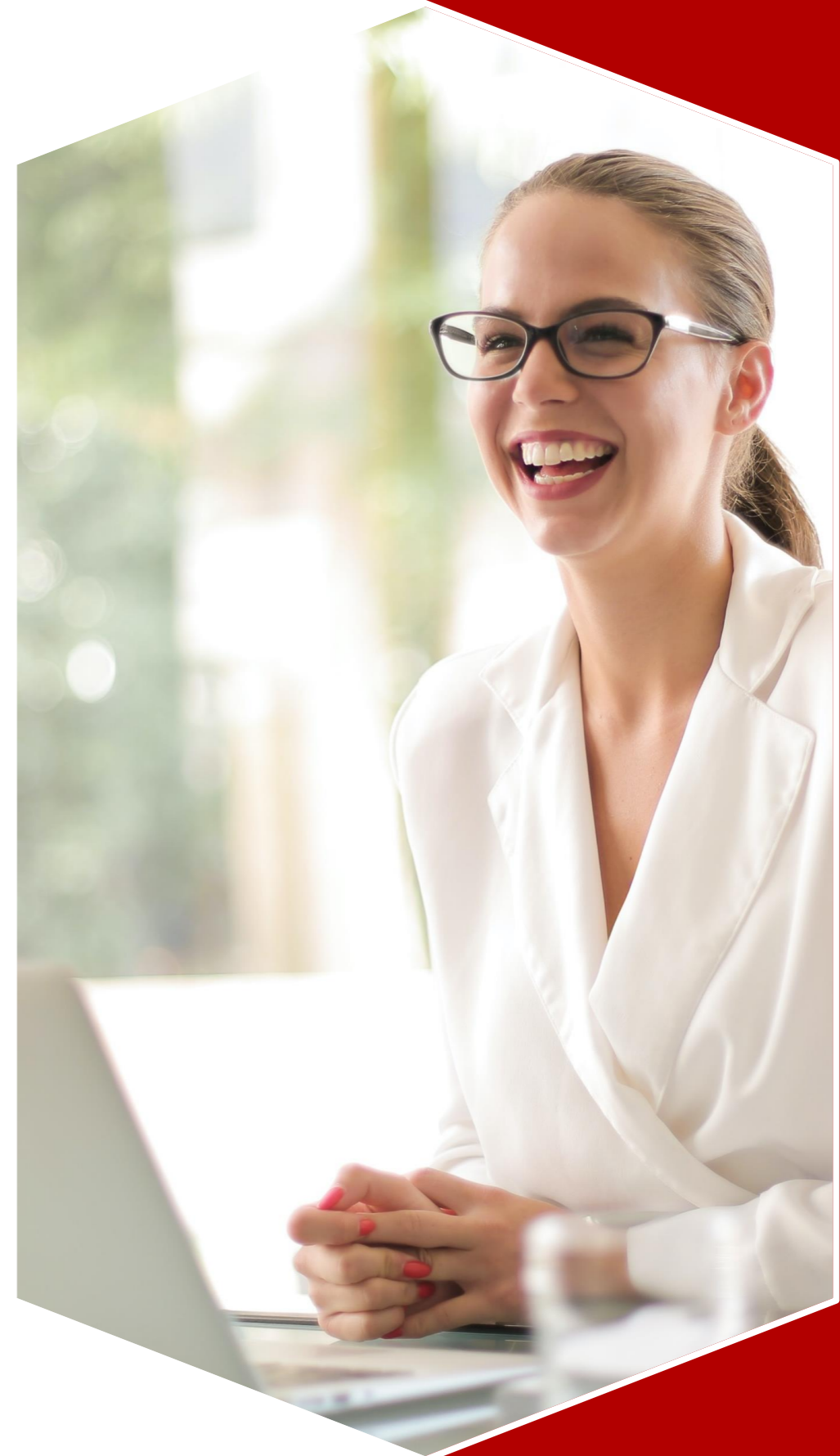
STARTUP VISA

REQUIREMENTS

- ✓ Have an endorsement letter from an authorised body that your business is feasible
- ✓ Have a brand-new business idea that is innovative and viable
- ✓ Have a minimum level of English Language at least CEFR level B2 in reading, writing, speaking and listening
- ✓ Be able to maintain yourself while you are in the UK. You need to have at least £945 in your bank account for 90 consecutive days before you apply

ROUTE TO PERMANENT RESIDENCE

Startup visa is granted for the maximum of 2 years, your visa can be further extended to a 3 years Innovator visa. On completion of 5 years you can apply for permanent residence in the United Kingdom.





INNOVATOR VISA

REQUIREMENTS

- ✓ Set up or run a business in the UK
- ✓ Have an endorsement letter from an authorised endorsement body that your business is feasible
- ✓ Prove that your business idea is brand new, not already trading, innovative, unique, and viable
- ✓ Have a minimum level of English Language at least CEFR level B2 in reading, writing, speaking and listening
- ✓ Be able to maintain yourself while you are in the UK. You need to have at least £945 in your bank account for 90 consecutive days before you apply
- ✓ Must have at least £50,000 in investment funds if you want to set up a new business

ROUTE TO PERMANENT RESIDENCE

Innovator visa is granted for the 3 years, you can apply for a further 3 years extension in the same category before expiry of your visa. Moreover, on completion of 3 years of leave in this category you may apply for settlement/Indefinite leave to remain, subject to the requirements.

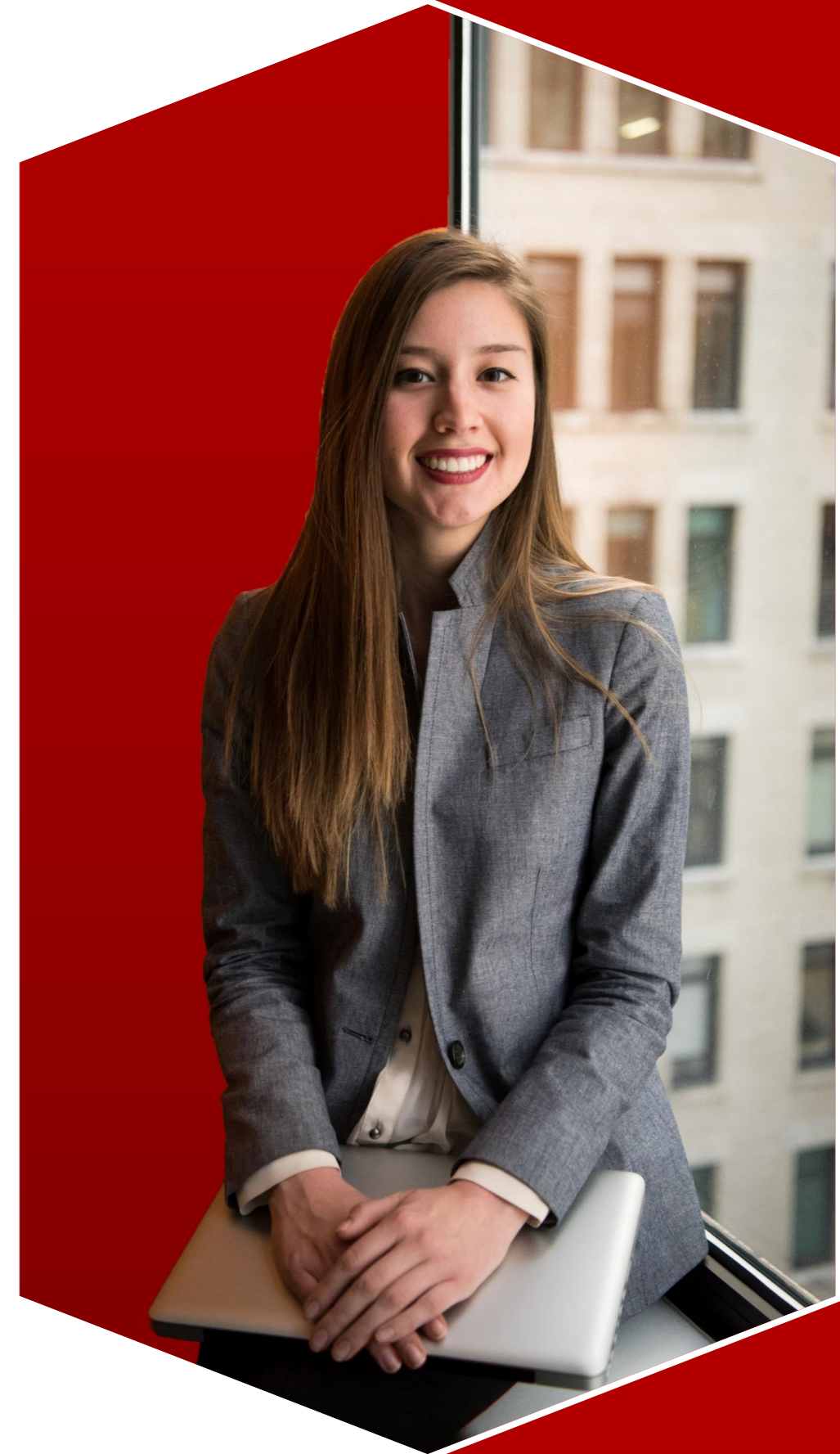
SKILLED WORKER VISA

REQUIREMENTS

- ✓ The employer must ensure the minimum job skill requirement of RQF 3 (Regulated Qualifications Framework) is met, which is less than a degree and is equivalent to A-levels
- ✓ The employer should check that the people they are hiring meet the work requirements to come to the UK
- ✓ The salary threshold starts from £20,480. The employer must pay the appropriate salary and meet salary requirements according to SOC codes
- ✓ Any applicants from outside the UK must also meet English language requirements

ROUTE TO PERMANENT RESIDENCE

Tier 2 (General) migrant can apply for settlement, i.e. for Indefinite Leave to Remain ('ILR') after having spent 5 continuous years lawfully in the UK





HEALTH AND CARE VISA

REQUIREMENTS

- ✓ You have a job offer from the NHS, an organization providing medical services to the NHS or an organization providing adult social care
- ✓ Your sponsor has told you that you are eligible for it
- ✓ You're a doctor, nurse, health professional or an adult social care professional

DURATION OF STAY

You can apply to extend your visa for up to another 5 years, as long as your total stay is not more than 6 years.

GLOBAL TALENT VISA

YOU CAN APPLY IF

- ✓ You can apply for this visa to work in the UK if you are a leader or a potential leader in either Academia or Research, Arts & Culture or Digital Technology
- ✓ You will also need to apply for an endorsement to prove that you are a leader or a potential leader in the above-mentioned fields
- ✓ After you get your endorsement, the earliest you can apply for a visa is 3 months before you travel and you will usually get a decision for your visa within 3 weeks if you are outside the UK and 8 weeks if you are inside the UK

DURATION OF STAY

You can apply to extend your visa for up to another 5 years, as long as your total stay is not more than 6 years.





BUSINESS VISITOR VISA

REQUIREMENTS

- ✓ A Business Visitor visa allows you to visit the UK for business and work-related reasons
- ✓ You don't need formal sponsorship from a UK-based sponsor
- ✓ You must have enough money to support yourself during your visit
- ✓ You must not intend to take on any other work in the UK, outside of what you've travelled for

DURATION OF STAY

On Business visitor visa you can stay in the United Kingdom for a maximum continuous period of 6 months.

SPOUSE VISA

REQUIRMENTS

- ✓ You and your partner must intend to live together permanently in the UK
- ✓ Your partner must either be a British citizen, be settled in the UK or have refugee status or humanitarian protection in the UK
- ✓ You must either be in a civil partnership or marriage that is recognized in the UK
- ✓ You must have a good knowledge of English
- ✓ Your partner must meet the financial requirements

ROUTE TO PERMANENT RESIDENCE

Once you complete your 5 years under this route. You will be eligible for Indefinite Leave to Remain in the UK.





STUDENT VISA

REQUIREMENTS

- ✓ You can apply for a student visa to study in the UK if you are 16 or over
- ✓ You have been offered a place on a course by a licensed student sponsor
- ✓ You have enough money to support yourself and pay for your course – the amount will vary depending on your circumstances
- ✓ You can speak, read, write and understand English

DURATION OF STAY

How long you can stay depends on the length of your course. A further extension of 2 years is granted for post study work, it can also be switched to various routes.

VISITOR VISA

YOU CAN APPLY IF

- ✓ You will leave the UK at the end of your visit
- ✓ You are able to support yourself and any dependents for the duration of your trip
- ✓ You are able to pay for your return or onward journey and any other costs relating to your visit
- ✓ You have proof of any business or other activities you want to do in the UK, as allowed by the Visitor Rules

DIFFERENT TYPES OF VISITOR VISA

- ✓ Standard visitor visa (long term)
- ✓ Academic visa
- ✓ Private medical visa

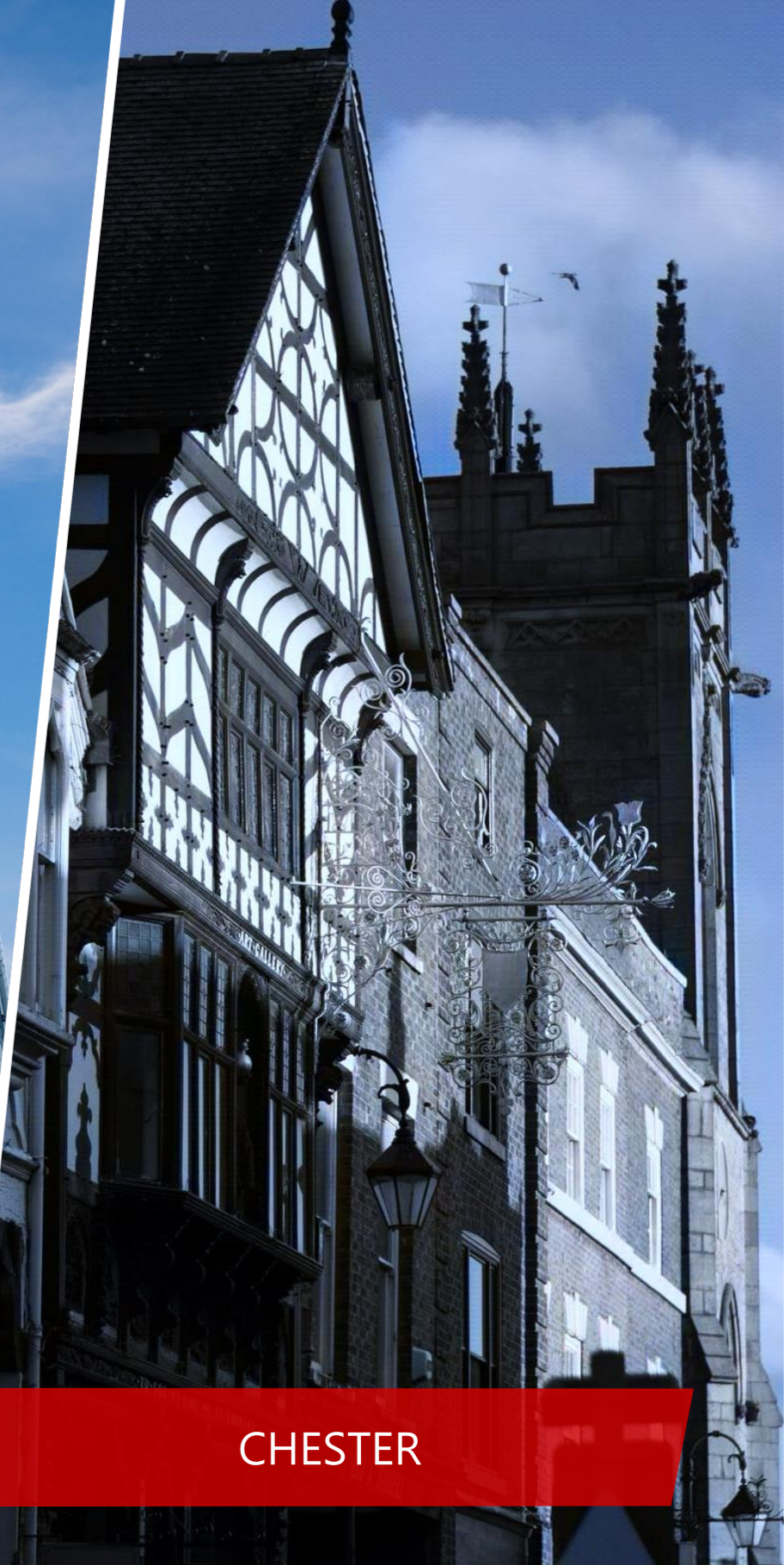
